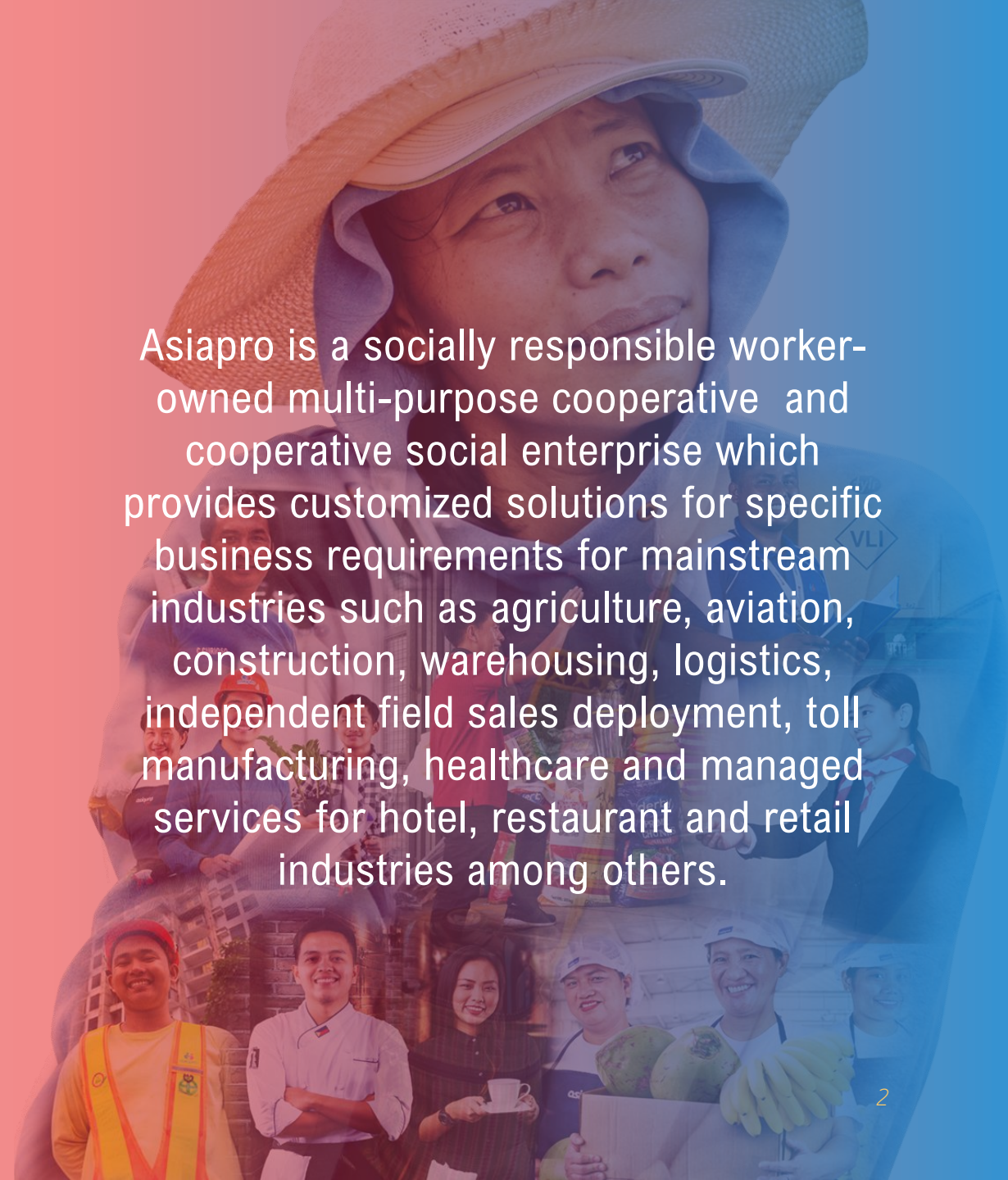

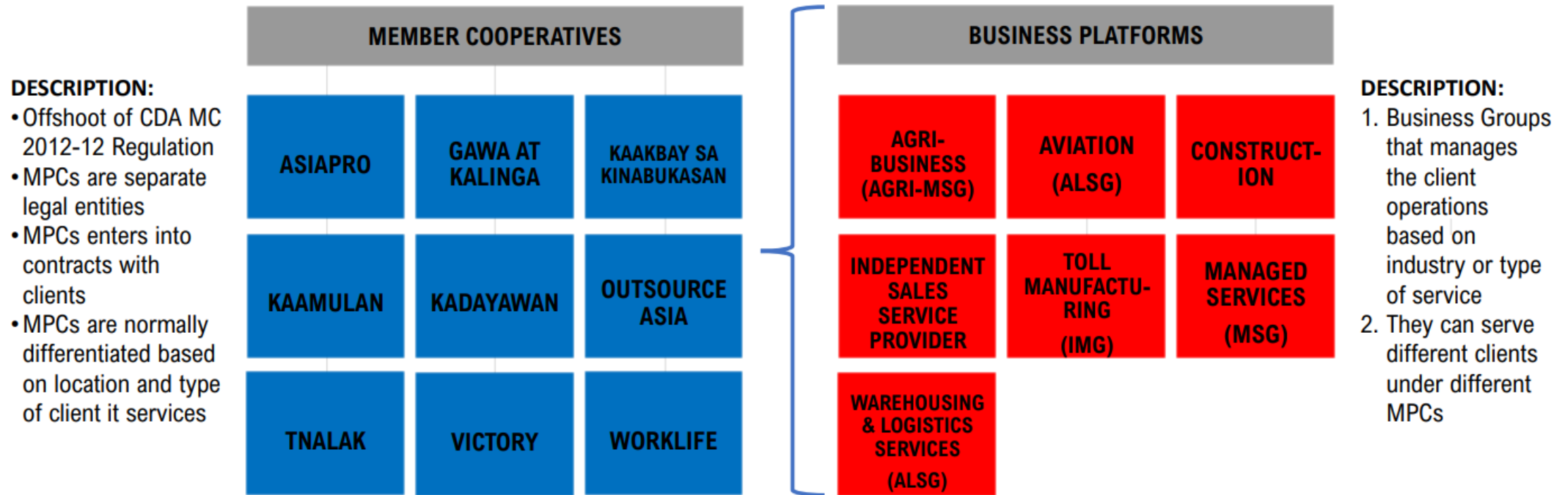
We are part of a larger Cooperative Network or Federation that are regionally based but operates as independent legal entities.

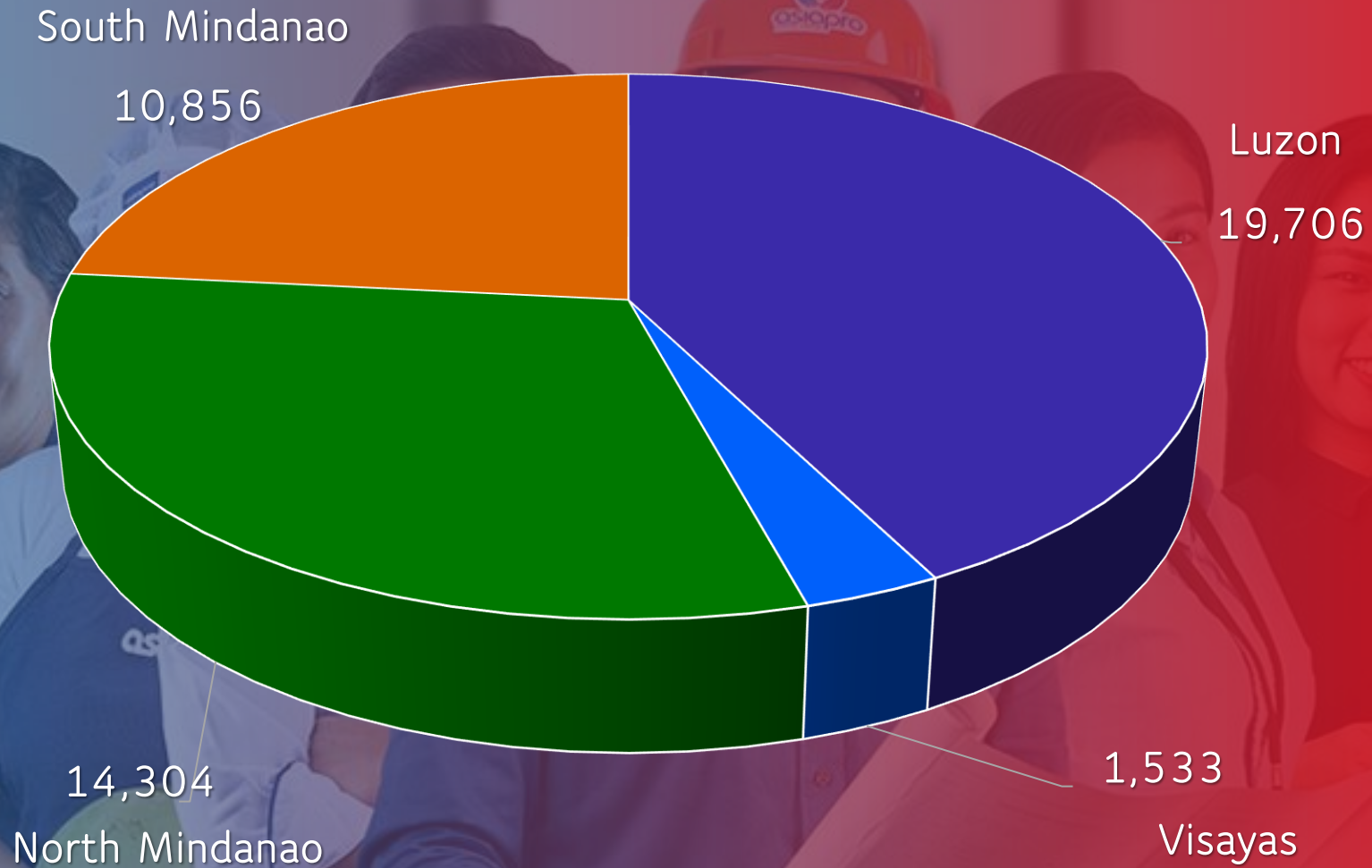

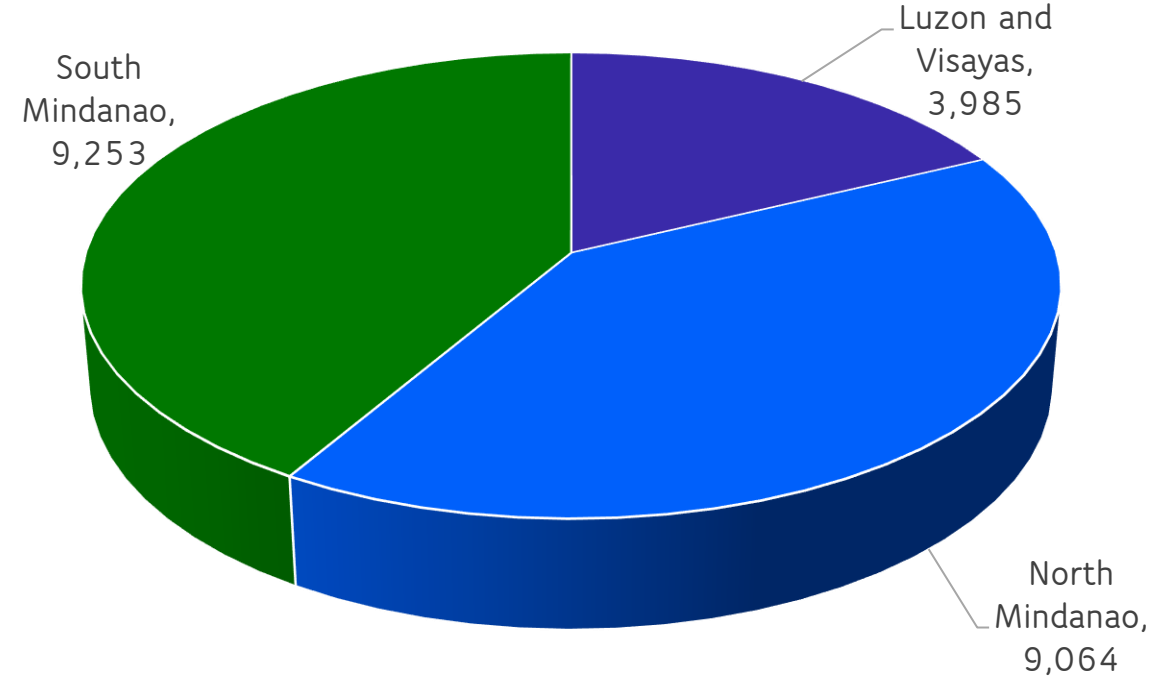
